## **Ph.D. Course work guide lines**

- As per Vidyasagar University Regulations Relating to Doctoral (Ph.D.) Degree 2017, after admission to Ph.D., a research scholar shall be required to undertake course work for a minimum period of one semester. All candidates admitted to the Ph.D. programme shall be required to complete the course work prescribed by the Department during the initial one or two semesters. Women candidates may be allowed a relaxation of two terms/ semesters in case of maternity.
- Candidates already holding M.Phil degree and admitted to the Ph.D. programme, or those who have already completed the course work in M.Phil/ Ph.D. and have been permitted to

process to the Ph.D. in integrated course, may be exempted by the Department from the Ph.D. course work. All other candidates admitted to the Ph.D. programme shall be required to complete the Ph.D. course work prescribed by the Department.

- 75% attendance for course work classes is compulsory.
- Teaching work per credit is 16 hours. (This may include lectures, seminars and tutorials).

#### Ph.D./SNT-01 – Research Methodology

**Part – A : Research Methodology** – Nature and objective of research, Meaning and Concept, Research method, Kinds, Criteria of good research, Major step in social research, Hypothesis, Sampling, Data collection, Sources, Bibliography and Referencing, Dissertation, Assignment and Thesis writing, Literature Review/ work done and deficiencies to do the works

**Part – B : Computer Application** – Basic knowledge of computer Application.

**Part – C : Basic Statistics** – Concept, Definition, Classification, Relation with other subjects, Collection and presentation of data, Table and diagrams, Variables and sampling, Major of central tendency – Mean, Median and Mode, Use of statistics etc.

#### Ph.D/SNT-02 – Subject Specific Topic

It comprises with Santali language and literature, Culture, Traditions, Festivals, Rituals, Socio-economic, Education, Health and Hygiene, Politics, History, Geographical study and other specific area of research relevant of the subjects also may be included. Special emphasis may be given in the interest area of researchable topics or subjects.

### **Ph.D/SNT-03-**

It comprises in four wings that are

- a) Seminar – A presentation will be prepared and deliver lecture on the subject/topic chosen by the candidates. It will be of 10-20 minutes time average presentation and its material maximum pages are not more than 10-20 and it will also be of 10-20 marks maximum only.
- b) Research Book Review – Research scholar or candidates must be review a previous research book in which Ph.D. degree are already been awarded to review them. How far that research book is successful or not, it would be point out through the mind of researchable candidate.
- c) Research Proposal – In proposed research topic or subject research scholar or candidate must be write up a complete research proposal not exciding 1000 – 2000 words along with 200 – 300 words research plan or Synopsis. It will also be carried maximum 10 – 20 marks only. Research proposal must be write up in following given up format – (i) Introduction, (ii) Needs and importance, (iii) Aims and objectives, (iv) Work done and deficiencies/ literature review, (v) causes of chosen, (vi) Limitation, (vii) Study methods to be applied, (viii) Outcomes, (ix) Relevance to the society and applicability, (x) Plan/ Synopsis, (xi) Working duration – It will be examined by oral and interview process.
- d) Research Article – A research scholar or a candidate must be also write about a research article related to the research topics along with full rules and regulations are to be follow up of a good research. It will be also comprises – Title, Chapter division, along with Bibliography and References etc. Written research article must be not less than 15 – 30 pages and words limit may be 1500 – 3000 words only.

### **Award of Grades :**

- A Ph.D scholar has to obtain a minimum of 55% of marks or its equivalent grade in the UGC 7-point scale (or an equivalent grade/CGPA in a pint scale wherever grading system is followed) in the course work in order to be eligible to continue in the programme and submit the dissertation/thesis.
- Maximum two chances shall be given to the scholar for clearing the course work, failing which may lead to cancellation of admission.
