Anthropological study of Peasants: Concept, definition and type of Peasantry. Tribal and peasant movements (Santal Movement and Tebhaga Movement).

Four (04) days fieldwork in a village or on a Tribe/Caste/ Community/ Occupational group for studying social organizational aspects of that village/community. Must include overall description of physical setting in short and aspects economic activities, family, marriage, kinship, religious practices. Drawing of Village Map and preparing Field diary are compulsory.

A field report based on the empirical work is to be submitted for evaluation.
