#### ***Course outcome:***

This course examines some of the path-breaking changes in Europe from around the mid-seventeenth to the late eighteenth centuries that ushered in the modern world. It seeks to develop an understanding of the forces of change that transformed the old regime. The course covers the origins of the Enlightenment, the growth of Mercantilism, and its impact on European economies, leading to the Industrial Revolution, as well as the development of Parliamentary monarchy and enlightened despotism.

Outline the changes and continuities in the field of an eclectic political and religious ideology in connection with the Bhakti movement and Sufi movements and delineate the development of trade and urban complexes during this period.

**Course outcome:** The local theme of this paper is to acquaint students with the growth of Indian nationalism after 1857 and the eventual foundation of Modern India. It throws light on several deeper and more nuanced developments of the 19th and 20th Centuries, which were the outcome of the emergence of nationalist consciousness and the awareness of colonial exploitation. The ideas and ideologies that transcend regions, linguistic, religious, and caste lines, fostering a collective national identity, are the subject matter of study. This period set the stage for the more organized mass movements of the early 20th Century, eventually culminating in India's independence in 1947. It experienced the partition of India and also its aftermath. The paper also incorporates the formation of 'New India' as dreamt by Nehru.

**Course outcome:** The syllabus is divided into four units. The syllabus aims to address the different issues in the history of Bengal and Bangladesh from 1905 to 1970. Unit one discusses the various political ideologies, swadeshi and boycott movements, the rise of extremism, and revolutionary activities in Bengal. These topics will discuss different struggles in Bengal against British imperialism. Unit Two discusses the rise, objectives, and activities of the All-India Muslim League. The role of Bengal in the national movement led by Mahatma Gandhi is a vital subject for discussion in the third unit. Still, we recognize that other genres should not be overlooked in this regard. Therefore, the ideologies of Deshbandhu Chittaranjan Das and Subhas Chandra Bose are of great significance in this context. Unit Three discusses the history of women and the changing socio-political status of women in Bengal from 1905 to 1947. Unit Four discusses the Partition of India, the birth of Pakistan, and the rise of Bangladesh. In this context, the causes of Partition, the role of Dr. Bidhan Chandra Roy as the maker of West Bengal, the Bhasha Andolan of East Pakistan, and Muktiyuddha, including the participation of the indigenous society and women, will be discussed.
