**MJ A4/B-4T: Early Modern Europe**

**Full Marks: 75**

***Course outcome:***

*This paper contextualizes the forces that account for the departure from the medieval cultural milieu. It starts with the collapse of feudalism and ends with the emergence of the early modern state. The paper aims to develop an understanding of the intellectual movements that contributed to the emergence of the Modern West. Thus, the paper includes the Renaissance, the Reformation, and the Scientific Revolution.*

**Course contents:**

- I. Political, social, and economic background:** Collapse of feudalism; the debate on the transition from feudalism to capitalism; the changing economic life in the 15th and 16th centuries; Shift of economic balance from the Mediterranean to the Atlantic; Commercial Revolution; the Price Revolution; monarchies and city-states; features of the early modern state. [No. of lectures: 18]
- II. Renaissance:** Italian city-states, merchants, the church, and the social context of the Renaissance; the origins of humanism, the rediscovery of the classics, and the impact of humanism on art, education, and political thought. [No. of lectures: 16]
- III. Reformation Europe:** The Background to the Reformation; Intellectual and Popular Anticlericalism; Martin Luther and Lutheranism, John Calvin, and Calvinism; Radical Reformation: Anabaptists; English Reformation and the Role of the State; Counter-Reformation. [No. of lectures: 16]
- IV. The Rise of Modern Science:** The Exploration of the New World, Technological Innovations, Portuguese and Spanish Voyages, Motives, the Printing Revolution, and the Scientific Revolution from Copernicus to Newton; the Emergence of a Secular Culture. [No. of lectures: 10]

**MJ A5/B5T: Modern India: 1707-1857**

**Full Marks: 75**

***Course outcome:***

*Students will be able to identify the significant developments in India's history during the period from the eighteenth to the mid-nineteenth century. It would highlight the downfall of the Mughal Empire as well as the rise of regional powers in India. This course explores the transformation of India during the eighteenth century under British rule. It would focus on British imperialist expansion in India, along with the establishment of the British Raj's governance apparatus and its impact on indigenous society and culture. The changes introduced in the rural economy and society, as well as trade and industry, will also be studied. Finally, the Course will address the revolts and reactions against the powers.*

- I. The downfall of the Mughal Empire & rise of the regional powers;** (a) Parties and politics at the Mughal Court, Crisis in Jagirdari System; (b) The rise of the Maratha power, Sikh power, and Bengal Nawabs. [No. of lectures: 10]
- II. Expansion and consolidation of British Rule:** (a) Mercantilism, foreign trade, and early forms of exaction from Bengal; (b) Dynamics of expansion, with special reference to Bengal, Mysore, Maratha, Awadh, and Punjab. [No. of lectures: 10]
- III. Colonial State and its Ideology:** (a) Arms of the colonial state: Army, police, Law, and Indian civil service;(b)Ideologies of the Raj: Orientalism, Utilitarianism; (c)Colonial state's attitude to social situations such as cast, tribe, and communities; relation to India; theory of rent; (d) Education: indigenous and western. [No. of lectures: 12]
- IV. Rural Economy and Society:** (a) the rural agrarian social structure; (b)Land revenue systems; (c) Commercialization of agriculture; (d)Rural society: Change and continuity; (e)The tribal dimension: the changing economy and society of the world. [No. of lectures: 12]

**V. Trade and Industry:** (a) Banking: Indigenous and Modern; (b) De-industrialization; (c) Trade and Fiscal Policy; (d) Drain of Wealth; (e) Growth of modern industry.

***Course outcome:***

*This paper will help the students to understand European history, beginning with the 1780s to the French Revolution and its aftermath, the restoration of old hierarchies, the emergence of democratic ideas, the rise of nationalism, and the remaking of States in the 19th and 20th centuries leading to imperialism, war, and crisis between 1880 C.E to 1919 C.E.*

**Credits 04; Full Marks: 75**

**Course outcome:**

*This course begins immediately after the Great Revolt of 1857 and introduces students to India's freedom struggle within a broader context. Beginning with the cultural, social, and religious reform movements that provided the ideological basis of the national movement, the narrative proceeds to the role of associations, moderate and extremist politics, and the Gandhian movements, including the Rowlatt Satyagraha and Jallianwala Bagh, Non-Cooperation, Civil Disobedience, Quit India, and the INA revolt. It deliberates on the ideologies and practices of RSS, Hindu Maha Sabha, and the Muslim League. It also covers negotiations for independence and partition, popular movements, partition riots, and finally, the emergence of a New State.*

**Course Content:**

- I. Cultural changes and Social and Religious Reform Movements:** (a) Growth of a new intelligentsia; the Press and Public Opinion; (b) Reform and Revival: Brahmo Samaj, Prarthana Samaj, Ramakrishna and Vivekananda, Arya Samaj, Wahabi Movement
- II. Nationalism: Trends up to 1919:** (a) Formation of early political organizations; (b) Moderates and extremists; (c) Swadeshi Movement; (d) Revolutionaries
- III. Gandhian nationalism after 1919: Ideas and Movements:** (a) Mahatma Gandhi: his Perspectives and Methods (b) Rowlatt Satyagraha and Jallianwalah Bagh (c) Non-Cooperation and Civil Disobedience; Quit India and INA (d) Left-wing movements.
- IV. Growth of the Muslim League and Its Impact.**

### **Course outcome:**

*This course will provide students with a comprehensive understanding of the process of power transfer and India's independence. This will also enable them to identify various political, social, and economic challenges faced by the newly independent nation. It will also make them accustomed to the process of development of parliamentary democracy in independent India.*

### **Course Content:**

- I.** Road to Independence: Wavell Plan, Mountbatten Plan, Riots, Negotiations for partition, Partition and rise of communalism. Partition literature and films. Refugee and migration problem in West Bengal and Punjab. Process of rehabilitation.
- II.** Integration of Princely States: (a) Hyderabad and Kashmir; (b) making of the Constitution of India.
- III.** The Nehruvian India: Domestic and Foreign Policies.
- IV.** Challenges to Congress rule, Lal Bahadur Shastri, and the war with Pakistan; the rise of Indira Gandhi; India's role in Bangladesh's liberation war.
