1. Understand the concept of childhood and child development in global and Indian, social, and cultural contexts.
2. Gain in-depth knowledge of the Four Fundamental Rights and Four Generic Principles enshrined in the United Nations Convention on the Rights of the Child (UNCRC).
3. Identify, analyse, and critically examine key child protection issues — including Child Labour, Child Marriage, Child Trafficking, and Child Abuse — along with their root causes and consequences.
4. Familiarise students with landmark legislations such as the Juvenile Justice (Care & Protection) Act, CLPRA, PCMA, ITPA, POCSO, and the Right to Education Act.

COURSE OUTCOMES:

Develop a clear understanding of child development stages, areas, and socio-cultural influences on childhood both in global and Indian contexts. Analyse the four fundamental rights and four generic principles under the UNCRC and explain their relevance to child protection in contemporary society. Critically examine the causes, consequences, and societal impact of critical child protection issues such as child labour, child marriage, child trafficking, and child abuse. Interpret key provisions of the Indian Constitution and evaluate the salient features of major child-related legislations (JJ Act, CLPRA, PCMA, ITPA, POCSO, RTE) and the legal remedies available under them.
